## Municipal solid waste

*Household waste delivered by Gympie region residents only.*

## General waste Includes Levy

*Includes construction and demolition waste, waste delivered under commercial arrangement, waste generated outside the Gympie region, and waste delivered by a person not residing in the Gympie region.*

### Terms of service:

1. Waste disposal charges are GST and levy inclusive. Waste disposal charges are to be paid by electronic funds transfer or cash at the time of disposal.
2. For approved credit account holders, invoices will be issued following the end of the month in which the disposal is made. Full payment of the balance is required within 30 days of issue of the invoice. Gympie Regional Council reserves the right to amend or remove the credit limit without prior notice, at Council's discretion.
3. Volumetric charges are rounded up to the nearest whole cubic metre.
4. Waste disposal fees are as specified by Gympie Regional Council in its annual budget and change each financial year.
5. Gympie Regional Council has the right in its sole and absolute discretion to limit the quantity and type of waste deposited in any waste disposal facility and to reject the deposit of any waste.
6. The site attendant or weighbridge operator is authorised to determine charges and is required to obtain information with regard to the source and type of waste.
7. Gympie Regional Council collects personal information where it is directly related to a function or activity of Council and where the collection of such information may be reasonably considered as necessary for that purpose. It will only use personal information for that purpose, and will not disclose it, except as permitted under Queensland's *Information Privacy Act 2009*.
8. Council determines the weight of loads for charging purposes by weighing vehicles before and after tipping where a weighbridge is installed, and/or by using average weights that are based on vehicle type, waste stream and GVM of the vehicle or vehicle combination. The average weights are derived from Queensland Government deeming criteria. The average weights or methodology used to determine load weights may be subject to review/change by Council.
9. Commercial loads over 500kg (of waste for landfill received at weighbridge sites) will be weighed and charged the tonnage disposal rate.
10. Mixed loads and/or loads of green waste, timber or recyclables (such as cardboard, mixed household recyclables, scrap metal) that are contaminated with other waste will be charged as General Waste.
11. Information such as the historic use of the facility by a customer (vehicle registration number as proxy), along with the type and size of the vehicle and/or the type and volume of waste will be used in determining whether a commercial waste disposal charge will be applied.
12. Commercial waste disposal charges apply to any waste transported to a waste disposal facility in a vehicle used for commercial purposes.
13. The levy on general waste delivered by residents is offset by an annual advance payment from the Queensland Government. General waste is not intended to include waste streams which are not from the normal operation of a dwelling. Examples of waste which are not from the normal operation of a dwelling might include major renovations, asbestos, material delivered in bulk quantities or in a commercial vehicle.
14. Disputes or requests for waivers or refunds should be addressed in writing to Council for determination.
15. Council reserves the right to prohibit access to waste management facility to persons who do not follow directions (on signage or given by on-site staff) or persons/businesses with outstanding waste disposal debts.
