Welcome to our third update for our *Better Pathways to Planning* project.

Our consultant recently provided us with their final report. The report, which is available to download on Council's [Better Pathways to Planning web page](#), describes the key findings from the one-on-one interviews, workshops, briefings and survey responses. The major findings highlight a need for better consistency, communication, transparency and project support.

The report also provides a list of recommendations for Council's consideration and further action. Some of the recommendations include:

- updating communication and engagement protocols
- improving communication and education materials
- learning from other councils
- mapping the customer experience.

I invite you to read the consultant's report in full and I hope that you can see your comments reflected in its pages.

Over the last week, Council's management team has been reviewing the consultant's report and developing an action plan that directly responds to the recommendations. A copy of the action plan will be made available over the coming weeks.

Yesterday, both myself and members of our executive team ran information sessions to share the report's key findings, our action plan for change, as well as the work that is already underway to improve people's experiences of our planning and development services.
