## Keeping of more than the prescribed number of animals – Application for approval/renewal of existing approval

## How to use this form

This form may be used to apply to Council for approval to keep more than the prescribed number of animals on a property within the region or to renew an existing approval with Council for the keeping of these animals.

It is a requirement of *Gympie Regional Council Subordinate Local Law No. 2 (Keeping of Animals)* that an approval is required to keep:

- More than two (2) dogs over the age of 12 weeks on any property\*, except where any additional dog is a working dog\*\*.
- One (1) or more dogs over the age of 12 weeks on any property\* that contains multiple residential units.
- More than two (2) cats over the age of 12 weeks on any property\*.
- One (1) or more cats over the age of 12 weeks on any property\* that contains multiple residential units.
- More than six (6) poultry on an urban property\*\*\* less than 800m2.
- More than 20 poultry on an urban property\*\*\* that is 800m2 or greater.
- More than 25 birds on an urban property\*\*\*.

**\*property** means a lot; or if a person owns and occupies 2 or more adjoining lots—the parcel of land comprising all of the lots owned by the person.

\*\*working dog means a dog usually kept or proposed to be kept on rural land; and by an owner who is a primary producer, or a person engaged or employed by a primary producer; and primarily for the purpose of droving, protecting, tending, or working, stock; or being trained in droving, protecting, tending, or working, stock; and does not include a class of dog prescribed under a regulation.

\*\*\***urban property** means a property of less than 4000m2 that is entirely or mostly within the boundaries of a zone, other than the Rural zone or Industry Investigation zone, defined in the local government's planning scheme.

## Approval period

Council's approval period to keep more than the prescribed number of animals on a property within the region runs 1 month after the registration period for dogs. The approval period has been set by Council as 1 December 2024 to 30 November 2025.

## Inspection of property for new applications

For new approval applications, a Council Ranger will conduct an inspection of the nominated property.

At this inspection Council's Ranger will evaluate, amongst other things whether:

- the enclosure provided for the animals is sufficient to prevent the animals from wandering or escaping from the property; and
- animal waste is disposed of in an appropriate manner; and
- for dogs, whether each dog is registered with Council or an application for registration of each dog has been submitted.

You are requested to nominate a preferred day / time for this site inspection to be undertaken as part of this application.

Inspections of properties are not usually undertaken for renewal applications.

## Additional requirements for keeping more than two (2) dogs on a property

### **Registration requirements**

It is a requirement of the *Animal Management (Cats and Dogs) Act 2008* ("the Act") for the owner of a dog more than 12 weeks old to register the dog in the relevant local government's area within 14 days after starting to keep the dog in the area unless the person has a reasonable excuse.

Each dog kept on the property must be registered with Gympie Regional Council except where any additional dog is a working dog\*\*.

You will also need to complete form HEF602 Dog Registration Application/Amendment of Registration. Please note that fees will apply to register each dog that is not microchipped and desexed.

### Dog breeder requirements

The Queensland Government has introduced laws to promote responsible breeding of dog. These laws apply to any dog born on or after 26 May 2017. A person who sells, advertises or gives away a dog, must have a Supply Number that identifies the registered Breeder of that dog. The supply number allows puppies to be traced back to their breeder. To obtain a supply number you need to register at https://qdbr.daf.qld.gov.au/.

If you are breeding animals on a commercial basis, a Development Approval may be required under the *Planning Act 2016*. Commercial animal breeders should contact Council's Development and Compliance Branch on 1300 307 800 for further information.
