Disaster recovery payment and disaster allowance

- > Currently available to eligible residents in 17 local government areas: Brisbane, Fraser Coast, Gold Coast, Gympie, Ipswich, Lockyer Valley, Logan, Moreton Bay, Noosa, North Burnett, Redland, Scenic Rim, Somerset, South Burnett, Southern Downs, Sunshine Coast and Toowoomba.
- > One-off, non-means tested payment of \$1000 per eligible adult and \$400 per child

Free replacement of birth/marriage certificates
