Action notice

The State Assessment and Referral Agency (SARA) received your referral agency material for the following premises on 10 January 2024.

Your development application is for a change application – other than a minor change, which means SARA must administer, assess and decide the application against the relevant provisions, as if the change application were the original development application, with the changes included, but made when the change application was made (see section 82 of the *Planning Act 2016*).

The application does not meet the requirements for a properly referred application under section 54 of the *Planning Act 2016*. The reasons for this decision are:
