SECTION 6: REPORT BY THE CORPORATE GOVERNANCE & FINANCE COMMITTEE CHAIRMAN

Cr Donna Neilson presented the following Report:-

The meeting learnt of the Community Group Flood Assistance Grants Program established by the Commonwealth Bank. The \$5 million fund

can be accessed by community groups that have suffered from damage and loss of equipment due to the recent flooding. Affected groups can access details from the Bank's website.

Emergency Management Queensland will be allowed to occupy office space in the Youth and Community Development unit for a further two year term. The Local Emergency Service Cadets has previously occupied the premises with no negative impact.

The meeting recommended that tenders be called for the sale of the Sandy Creek Hall and the land having an area of 4047 square metres. As the hall is no longer used by the community and there is no active Hall Committee it was resolved to sell the hall after rezoning from 'Community' to the Rural zone. The proceeds of sale will be used towards the maintenance of other halls in the region.

It was recommended that Council offer a lease over land at Sandy Creek Road, Victory Heights to the Gympie Sporting Clays Inc. The Club currently occupies land at Sexton, but most of their infrastructure has been destroyed in recent flooding. The meeting also requested that the Mayor make representations to the State Government to progress the proposed Regional Shooting Facility in the Curra State Forest.

Malcolm Blaylock and Brett Houghton from the Heart of Gold Film Festival addressed the meeting in relation to support for the 2012 festival. Council will waive the hire fees for the use of Dickinson Park for the purpose of running the Goomeri Pumpkin Festival.

Gympie Regional Council has received a bronze award in the national 50:50 Vision – Councils for Gender Equity program. The scheme encourages councils to address gender equity issues within the organisation and among elected representatives.

As per Minute G38/02/11, Council is obliged to inform the Minister for Local Government of its decision on Electoral Arrangements as soon as possible following the conclusion of the consultation period.

Of the 632 Questionnaire responses received, 53 have not been able to be verified as being from currently enrolled 'electors'.

Of the 53 unverified responses included in the totals above, 17 voted for No Divisions, 36 voted for Divisions.

Of those who voted for Divisions and nominated a preference, 232 voted for Single Member Divisions, 142 voted for Multi-Member Divisions.

The above represents a response to the Representation Questionnaire from approximately 2% of the electors enrolled for the Gympie Regional Council area as at January 2011.
