# SECTION 6: REPORT BY THE COMMUNITY & ECONOMIC DEVELOPMENT COMMITTEE CHAIRMAN

Cr Tony Perrett present the following Report:

The Committee received the Health and Environmental Services report for the month of June noting the ongoing upgrade and maintenance at the Southside Waste Management Facility. This works includes;

- the bitumen sealing of a new pad adjacent to the recycler's shop and relocating the waste transfer & recycling bins to this area
- construction of grass swale drains and water control devices
- construction of a dedicated green waste area
- modification of the dedicated metal waste area
- construction of an inspection track along the northern batter
- maintenance of the northern firebreak/access track

An application by the proprietor of the Rainbow Beach Massage and Natural Therapies Centre for an approval to operate a beach massage service adjacent to the patrolled area at Rainbow Beach has the Committee recommending, that an onsite meeting be held with

Councillors and relevant staff to ascertain whether there is sufficient beach area available to approve this request. The matter will be reported back to the next meeting of the Community Services and Economic Development Committee.

The Committee recommends that an application for itinerant vending permit to allow the sale of ice cream on Council controlled roads be approved subject to the following condition; that the applicant must not vend on a road, public place or within a local government controlled area that is closer than 500 metres of an existing retail shop, shopping centre or roadside vending stall selling the same or similar goods; or school (between 7am and 5pm on school days); or public swimming or recreational facility or ground where sport is played and the same or similar goods are sold as part of that facility; or a place where a fete or market is operating unless they're part of that event.

The new owner of the Rainbow Beach Surf School has written to Council seeking approval to transfer the Beach Use Licence currently held by the previous owner to their name. The Committee recommends that Council approve the transfer subject to the commercial activities and conditions remaining unchanged. This approval will expire on the 30 June, 2012.

The Compliance & Local Disaster and Community Facilities & Services reports for the month of June were received with no notable concerns.

The Economic Development and Public Relations Officer's report was received noting the success of the Goomeri Business Leaders forum held in June. A series of other business meetings have been organised across the Region with the relevant local Chambers of Commerce. These forums provide an opportunity for Council to raise the awareness of Council's Economic Development Strategy as well as hearing directly from business owners about any business related concerns they might have.

The general manager of Gympie Cooloola Tourism, Amanda LePeilbet presented the monthly Tourism report noting the success of their attendance at the Brisbane Caravan and Camping Show at the RNA Showgrounds. Twelve (12) boxes of holiday guides and other promotional material were distributed during the event. Promotional and advertising work continues across the State with television advertising being aired in Toowoomba and Rockhampton. Radio and print media advertising also featured heavily during June.

**Executive Summary:** 

Following the introduction of the new Local Government Act 2009, Council is required to review the delegations register to reflect the necessary changes.

King and Company Solicitors have been engaged to review the current Instruments of Appointment in line with the changes brought about by the introduction of the new Local Government Act 2009.

The Register has been prepared in accordance with the requirements of Section 257 of the Local Government Act 2009 for each power under the Local Government Act or another Act which may be delegated by Council to the Chief Executive Officer and Section 259 of the Local Government Act for each power of the Chief Executive Officer which may be delegated by the Chief Executive Officer to an appropriately qualified employee or contractor of Council.

Attachment 1, Gympie Regional Council's Delegations Register from Council to the CEO contains the relevant legislation at the time of compilation by King and Co. Solicitors.

It is noted that amendment of legislation is an ongoing process and as such the Delegations Register will need to be amended as and when changes in relevant State Legislation occurs.

Accordingly it is noted pursuant to Section 260 of the Local Government Act 2009 provides that Council's CEO must establish a register of delegations that contains the particulars prescribed under a regulation and must record all delegations by Council, the Mayor or the CEO in the register. The public may inspect the register for delegations.

On Census night, every person in Australia must complete the Census by either filling in the paper form or through eCensus online.

Water and Other Legislation Amendment Bill 2011 (Qld)

Cr Walker tabled the following correspondence from Mary River Catchment Co-ordination Committee.

"MRCCC submission to the Parliamentary Environment, Agriculture, Resources and Energy Committee regarding the Water and Other Legislation Amendment Bill 2011 (Qld)

#### MRCCC sector representatives

Under the new parliamentary committee system, Bills to introduce or amend legislation are considered by a multi-party committee before being presented in Parliament, along with a report and set of recommendations from the committee. These committees have the ability to hold inquiries and call for public submissions as part of their work. The Water and Other Legislation Amendment Bill 2011 (Qld) is currently being reviewed by the Parliamentary Environment, Agriculture, Resources and Energy Committee, and they have invited public submissions. Closing date for written submissions is Friday 12 August 2011. Information submitted to the committee is protected by Parliamentary privilege.

Several of these proposed changes to water legislation are significant from a MRCCC perspective and the executive has asked that MRCCC staff prepare a brief submission. This is unpaid work, and MRCCC sector representatives may like to assist by reviewing the proposed legislative changes, considering the likely impacts on their sector and reporting back to MRCCC staff so that their concerns can be reflected in the MRCCC submission.

Here is a summary of the parts of the bill that have raised concern so far:

- establish a Single Process framework for the concurrent development of a water resource plan and resource operations plan. The amendments also remove the requirement for establishment of community reference panels (CRPs) and provide discretion to employ a shortened process in certain circumstances, for example, if a replacement plan is not materially different to the existing plan;
- simplify the notification of works process by relocating the process from the Water Regulation 2002 (Water Regulation) and water resource plans to the Water Act;
- introduce an amendment to enable the South East Queensland water grid manager and the Commonwealth Environmental Water Holder to apply for a water licence not attached to land and to engage in dealings with water licences, for example, enabling a water licence already attached to land to be transferred to these entities. This amendment is intended to provide the flexibility necessary for these entities to achieve the significant water reform activities for which they were originally established;
- provide an exemption from the requirement to hold a riverine protection permit if works that take or interfere with water are made self-assessable under a water resource plan or regulation and the works are being constructed in accordance with a selfassessable code listed in the Water Regulation.

If you want to find out more about the bill, or want to help with researching and preparing a submission (either the MRCCC's or your own) could you please contact me during the next week (in light of the brief timelines). It is worthwhile reading the legal opinions in the explanatory notes about this bill with respect to how the proposed amendments contravene the Legislative Standards Act. This Bill definitely reduces opportunities for public consultation in Water Resource Planning, which is a step in the opposite direction to the stated aims of the MRCCC and the National Water Initiative.

On the bright side - doing the research for this is how I found that Traveston Crossing Dam has been removed from the Water Act and State Development Act regulations - and I am very happy about this discovery."
