#### 1. BACKGROUND AND PREVIOUS COUNCIL CONSIDERATION

In January 2020 Sunshine Coast builder Ri-Con Contractors Pty Ltd went into liquidation leaving debts to subcontractors and secured creditors. This included local Gympie subcontractor O'Brien Plumbing who was among those impacted for work undertaken at the Kilkivan Equestrian Centre and the Gympie Youth Hub.

At its Ordinary Meeting on 4 March 2020, Council resolved via minute M10/03/20:

"That council instructs the CEO to cooperate fully with any official investigation relating to the collapse of Ricon, by providing all information and any documents that relate to the investigation and that staff be instructed by the CEO to assist and cooperate with official investigators at all times. "

#### 2. REPORT

In their efforts to recoup outstanding payments owing to them a request has been made by O'Brien Plumbing to Council to produce the following information:

- 1. Copies of the statutory declarations or any documents that Ri-Con submitted to Council in regard to payments
- 2. A copy of the insurance policy Ri-Con gave for both the Kilkivan Equestrian Centre and The Gympie Youth Hub Projects
- 3. A copy of the tender document pack that was sent to Ri-Con Contractors for both the Kilkivan Equestrian Centre and The Gympie Youth Hub Projects.

With respect to item 2 above, Council requests copies of Certificates of Currency for various insurances required via the tendering process. Council is not in possession of any insurance policy document(s) in relation to the above matter.
